Q	How would rate the MS in contract management program at NPS?
Α	Since I was a PM and not a Contract Specialist when I enrolled in the program, I found the program to be very engaging and it really increased my learning about the DoD contracting process. It is the equivalency of DAWIA Level 2 and Level 3 education for Contracting. The networking opportunities
	were also excellent. I highly recommend the program.

_	l assume this question pertains to the new DoD Small Business Professional Credential (CSBP 001) deployed by DAU on 30 April 2021.
Q	Who has priority for the credential courses?
A	Priority for the virtual/classroom credential courses (SBP 102V, SBP 202V and SBP 210/V) is determined by the service or 4 th Estate Director, Acquisition Career Management (DACM). The two on-line credential courses (SBP 101 and SBP 201) have no priority for enrollment.
Q	The Credential CSBP 001, is comprised of a group of assets (in this case 5 SBP courses) plus a comprehensive credential exam. I've heard CSBP 001 referred to as a course and the credential assessment as a course and just wanted to correct that.
Α	This is a statement made in the chat during the event. The Small Business Professional Credential (CSBP 001) requirements consist of five SBP courses and a fundamentals exam.
