SAM.gov Methodology Changes

Department of the Navy Office of Small Business Programs

As of 11 August 2021 the following RISE Act / National Defense Authorization Act (NDAA) 2019/2020 changes are applied to Small Business related awards in SAM.gov:

• Small Business Awards will be *double credited* if either of the following conditions are met:

- Small Business awards done as a Local Area Set Aside
- Small Business awards to a Small Business headquartered in one of the following territories:
 - Puerto Rico
 - ≻ Guam
 - > U.S. Virgin Islands
 - American Samoa
 - Northern Marianas Islands

- If an award meets both of these conditions it is only double credited once
- Double credit for these awards will continue until 30 September 2022
- These "double credit" Small Business awards are only applicable to Small Business, Small Disadvantage, Service-Disable Veteran Owned, Women Owned, and HUBZone awards
 The "double credited" amount is NOT added to the Overall Total Awards

 - Help tab has an edit feature that allows Admins to directly edit their MajComs the Super User contact information
