JOINT VENTURE BASICS

- MPA approval required prior to JV bid on award
- SBAMPP does not review or approve JVs
- SBA District Offices approve JVs for 8(a) contracts
- MPA JVs are granted exclusions from affiliation
- MPA JV contracts awards are limited to the 3-in-2 rule
- Procuring activities must consider work done individually by each partner to the joint venture as well as any work done by the joint venture itself.
- Protégé firms must perform at least 40%, Mentor firms may perform up to 60%
